NOTE:

- Applying this patch to the 3PAR OS might restart the affected OS components. With these
 restarts, events and alerts might be generated and this is an expected behavior. The system
 continues to serve data, but existing CLI or SSMC sessions might be interrupted.
- Hewlett Packard Enterprise recommends installing patches in the same sequence as they are released, unless instructed otherwise.
- When displaying the showversion command output from the SP, the CLI Client version is fixed in the SP code and might differ from the output displayed from any other system.

Patch 92 includes:

Issue ID	Description
199754 212401 211833	Corrects an issue when upgrading drive FW on DOPE drive models, the drive becomes unresponsive and rejects I/O requests
178672 199904 168180	Prevents an unexpected controller node restart when region moves occur on Thinly Provisioned Virtual Volumes (TPVVs).
184963	Corrects an issue where Remote Copy LUNs were inaccessible to the host when the LUNs are in a transitioning state during System Manager startup, even when this was no issue on the secondary array in the Remote Copy configuration.
205730	Prevents unexpected controller node restarts when the DDCscan encounters a VV that has already been removed as a result of vvcopy or promotevv that has not completed successfully.
188681 212903	Resolves an issue with Asynchronous Streaming Remote Copy configurations where on the primary array, during controller node recovery, metadata was not properly processed which lead to an unexpected controller node restart.
209286	Corrects a situation when running compactepg on CPG containing a fully provisioned VV with set size of 6+1 and 8 TB, or greater in size, the System Manager becomes unresponsive.
170695	Addresses an issue where the array becomes unresponsive due to system level TDVV snapshots that are not removed when the TDVV RW snapshot is removed.
210195	Resolves an issue where an array with six controller nodes will experience a decreased dedup ratio. This issue does not affect arrays with a two, four or eight controller nodes.

Issue ID	Description
188463	Resolves an issue where, after properly shutting down the array, if a power regulator failure prevents a controller node from booting, the array will not become available to serve data because it is waiting for the missing controller node to boot.
213124	Prevents unexpected controller node restarts, which can lead to an unexpected array restart, when snapshots are removed out of order.

Verification

The installation of P92 can be verified from an interactive CLI session. Issue the showversion -a -b CLI command to verify that P92 is listed:
