1 Introduction

This document describes how to configure the Single Radio Voice Call Continuity (SRVCC) service in the MTAS.

1.1 Prerequisites

It is assumed that the user of this document is familiar with the O&M area, in general.

1.1.1 Licenses

To enable the SRVCC service in the MTAS, the SRVCC license must be installed.

2 Overview

This document describes the SRVCC function of the Service Centralization and Continuity Application Server (SCC-AS) based on the MTAS architecture.

The SRVCC function allows voice call continuity between IMS over Packet Switched (PS) access and Circuit Switched (CS) access for calls that are anchored in IMS when the User Equipment (UE) is capable of transmitting or receiving on only one of those access networks at a given time.

SRVCC access transfer is supported for the following cases:

- Ongoing active calls
- Calls in alerting state
- Calls in originating pre-alerting state
- MSC assisted Mid-call feature

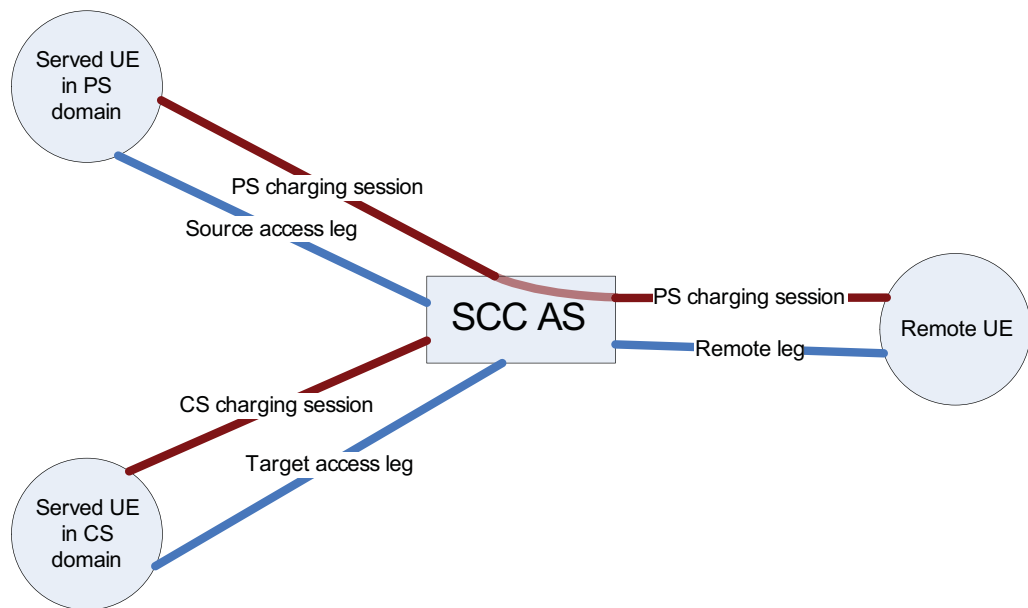


Figure 1 Overview SRVCC Session

The naming of the various legs and charging sessions are shown in Figure 1.

The following notations are used in the signaling charts for identifying the charging sessions:

PSC	PS charging session (original)
CSC	CS charging session (for the target access leg)

2.1 Subfunctions

The subfunctions included in the SRVCC service are described in this section.

2.1.1 Registration Procedure

During SIP registration procedures, the SRVCC service stores the C-MSISDN value of the served UE. The C-MSISDN value is used during access transfer for identifying the session to be transferred.

If the SRVCC R10 procedure is deployed in the corresponding IMS network, then the SRVCC service also stores the Session Transfer Number - Single Radio (STN-SR) value allocated dynamically to the C-MSISDN. The SCC-AS updates the Home Subscriber Server (HSS) with the new dynamic STN-SR value during the registration procedures. The HSS propagates the new STN-SR / C-MSISDN allocation in the network. The stored STN-SR value is used in the subsequent registrations for identifying if it is changed and is propagated again.

If HSS-based ATCF Info storage and restoration function is enabled, then SCC AS stores the ATCF Info of the registered user in HSS as transparent data during the registration procedure and removes it during the deregistration procedure.



SCC-AS updates the ATCF with the ATU-STI associated with the C-MSISDN of the registering contact. The update is done by sending a MESSAGE directly to the ATCF. If routing through I-CSCF is needed, DNS must be configured to resolve ATCF name to I-CSCF IP address. Transport protocol in DNS SRV request is in accordance to `mtasSipProtocolMtasOrigCall` parameter.

SCC-AS supports the enhanced registration procedure as of 3GPP Release 12, where ATCF advertises towards S-CSCF that all MSCs in the same serving network as ATCF support access transfer of calls in alerting and pre-alerting phase and MSC assisted mid-call feature. This is made through the feature tags in the Feature-Caps header of the REGISTER message, `g.3gpp.srvcc-alerting`, `g.3gpp.ps2cs-srvcc-orig-pre-alerting`, and `g.3gpp.mid-call`.

Those feature tags are stored internally in SCC-AS with the registered contact, to be used later together with feature tag indication from SC UE at session anchoring and operator policy configured in SCC AS to determine if the SRVCC pre-alerting, alerting, and mid-call features can be applied.

The registration information could be lost by a node restart or an SCC-AS failover. In these cases, the registration information is obtained during the call setup by the registration event subscription method. The registration information is retrieved from the S-CSCF which acts as a notifier. After processing the registration information, the registration procedures are the same as at third-party registration.

SCC-AS supports the Ericsson-specific extension of the registration event subscription to be able to perform the SRVCC R10 handover after a restart or failover. If there is no Ericsson-specific extension of the registration event subscription and HSS-based ATCF Info storage and restoration function is enabled, then SCC AS restores the ATCF Info from HSS.

2.1.2 Service Unavailable during Access Transfer

The served UE in the PS domain can terminate an existing session owing to service unavailability with BYE(503) request or an early dialog with CANCEL(503) request with a Reason header containing protocol “SIP” and reason parameter “cause” with value “503”. Such a request is not immediately forwarded by SCC-AS to the remote UE. It is delayed by the SRVCC service for an operator-defined time. If during that time an access transfer is initiated by the served UE in CS domain, then the BYE or CANCEL request is not forwarded but the access transfer procedures are started, see Section 2.1.3 Access Transfer of Ongoing Active Calls on page 5.

2.1.3 Access Transfer of Ongoing Active Calls

The served UE in CS domain initiates the access transfer by sending an INVITE request to the SCC-AS. When access transfer is initiated, the UE that is the subject to the transfer is identified by its Mobile Correlation Subscriber Integrated Services

Digital Network (C-MSISDN) value that is specified by the P-Asserted-Identity header of the INVITE request.

A UE can have multiple sessions but only one session is transferred according to the applied SRVCC R9 or R10 procedures as follows:

- The R9 procedure has an active full-duplex speech media component that was most recently activated.
- The R10 procedure is pointed by the Target-Dialog header in the received INVITE.

Only the speech media is transferred, the other media components are terminated by the SCC-AS.

Before the access transfer SCC-AS acts as a Back-to-Back User Agent (B2BUA), it forwards the SIP signaling between the source access leg and the remote leg. After successful access transfer, the SIP signaling is forwarded between the target access leg and the remote leg. There is a transient period during the access transfer when the source access leg and the target access leg coexist. During that transient period the served UE in PS domain has the possibility to revert the access transfer. This is initiated by a re-INVITE request sent by the served UE in PS domain. During successful access transfer, a new charging session is created for the target access leg and the original charging session is kept as well. The two charging sessions are terminated when the transferred session is terminated.

2.1.4 Access Transfer of Calls in Alerting State

When SRVCC Rel-10 architecture applies, and the session subject to access transfer is in alerting state (originating or terminating), the access transfer INVITE with Target-Dialog header pointing to the PS session to transfer is proxied by the ATCF to SCC AS. If support for access transfer of alerting call is enabled in SCC AS, ATCF, MSC, and the served UE, the access transfer of calls in alerting state is performed as per the transfer procedure mentioned in [3GPP TS 24.237](#) version 10 and onwards.

2.1.5 Media Update at AccessTransfer

When access transfer happens according to the SRVCC R10 architecture where the media is anchored in ATCF/ATGW in the serving network, normally, any differences in the speech media component between currently used media on PS session and the media offered in the access transfer INVITE from MSC is handled and transcoded in the ATGW. The same speech media can be used in the offer from the ATCF to the SCC AS at the access transfer as currently used, and the remote UE does not have to be renegotiated from SCC AS. This is also the idea with SRVCC R10 architecture. However, this is not always the case. The used ATCF/ATGW maybe not support a specific codec or the call case does not allow for selecting a specific media to be used in the access transfer INVITE, for example, originating (pre-)alerting case with multiple early sessions to transfer. For this purpose, a media comparison procedure is supported in SCC AS at



access transfer to judge if remote side needs to be renegotiated or not. When the comparison results in “false” (no match), the remote side is renegotiated using the SDP from access transfer INVITE. The procedure is controlled with the CM attributes `mtasSrvccMediaCheck`, `mtasSrvccMediaCheckAttributes`, and `mtasSrvccMediaCheckBandwidth`.

2.1.6 Access Transfer of Originating Calls in PreAlerting State

When SRVCC Rel-12 architecture applies and the session subject to access transfer is in originating pre-alerting state, the access transfer INVITE with Target-Dialog header pointing to the PS session is proxied by the ATCF. If SRVCC release is R12 and support for access transfer of originating pre-alerting call is enabled in SCC-AS, ATCF, MSC, and served UE, the access transfer of calls in originating pre-alerting state is performed as per the transfer procedure mentioned in 3GPP TS 24.237 version 12.6.0.

2.1.7 Access Transfer with MSC Assisted Mid-Call Feature

If support of MSC assisted mid-call feature is enabled in SCC AS, ATCF, MSC, and the served UE, the following use cases can be supported during SRVCC access transfer:

- Access transfer single Held call
- Access transfer Active call and additional Held call
- Access transfer Held call and additional outgoing call in (pre-)alerting state
- Access transfer Active call and additional Held call

2.1.8 Post-transfer Procedures

After successful access transfer, SCC-AS acts as a simple B2BUA but it has to maintain two related charging sessions; the original charging session and the charging session for the target access leg.

2.1.9 Fallback to Rel-9

SRVCC fallbacks to Rel-9 procedure if the STN-SR stored in HSS has same value as `mtasSrvccStnSr`, or the access transfer INVITE from the served UE in CS domain does not have a Target-Dialog, or the Request URI in the access transfer INVITE does not point to the ATU-STI PSI.



2.1.10 Operation and Maintenance Operations

The O&M operations specific to the SRVCC service are as follows:

- Configuration of node level parameters
- Collection of measurement data
- Management of the alarm raised by SCC-AS

2.2 Interaction with Other Services

This section describes how the SRVCC service interacts with other services.

2.2.1 Terminating Access Domain Selection

After successful access transfer, the access type of the served UE is changed from PS to CS. If Terminating Access Domain Selection (T-ADS) procedures are applied after successful access transfer, T-ADS service is aware of the new access type.

3 SRVCC Configuration

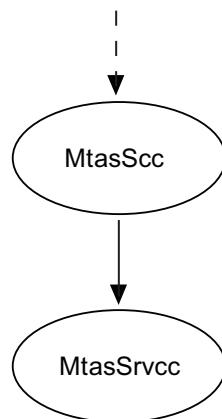


Figure 2 SRVCC MO Structure

The SRVCC service is controlled by the **MtasSrvcc** Managed Object (MO). An overview of the SRVCC MO structure is shown in Figure 2.

3.1 Configuration Activities

This section describes configuration activities.

3.1.1 SRVCC Configuration

The configuration activities are listed in Table 1.

It is assumed that all MSC Servers in the network where the UE is registered which can be involved in the SRVCC procedures support SRVCC for calls in originating prealerting phase.	mtasSrvccOriginatingPreAlerting
Sets which bandwidth type (bwtype) parameters to be included in the media comparison procedure when mtasSrvccMediaCheck=2. The supported bwtype parameters are AS, RR, and RS. 3.2 SRVCC Administrative State Configuration

The SRVCC service is enabled by setting the `mtasSrvccAdministrativeState` attribute in the `MtasSrvcc` MO to 1 (UNLOCKED). If the `mtasSrvccAdministrativeState` is set to 0 (LOCKED), no SRVCC service is provided by the MTAS.
