Summary: This Technical Note informs about the change in the naming practice for

UltraSite EDGE BTS product documentation releases.

Description: From BTS SW CX4.1 onwards the naming of the BTS Software releases and correction packages will be changed. This has been communicated in Technical Note No. 46.

So far, the UltraSite BTS Product Documentation sets' release identifiers have only indicated the release of the documentation set itself, but the relation of these release identifiers to a BTS SW release has not been clear. In line with the changed naming of BTS SW releases, UltraSite BTS Product Documentation sets (i.e. NEDs) will start to be named according to the related BTS SW releases, e.g. *Nokia UltraSite EDGE BTS, CX4.1, Product Documentation*, which will be the first BTS Product documentation set following this practice. According to the old naming practice it would have been named *Nokia UltraSite EDGE BTS, Release 7, Product Documentation*.

This approach will be in harmony with the naming practice in BSC documentation and BSS system level documentation. It will also provide better visibility on what the documentation contains, as BTS product documentation also includes SW release-specific information: alarm descriptions, commissioning instructions, and SW feature descriptions.
