High/Safety - Perform Immediately

#### **Symptoms**

After upgrading the Zone Controller to ZC-Astro-32.01.03.62-01 in a zone with conventional sites, the Zone Controller will experience a condition where conventional site links reset every 3 seconds. UEM reports Critical Alarm for Control Paths: DOWN, CCGW-ZC Connection Lost. - No Activity from Site XXXX, Control Path X.

#### **Workaround/Recovery**

Revert any Zone Controller running version ZC-Astro-32.01.03.62-01 in an ASTRO® 25 system to the previous version. **Do not install ZC-Astro-32.01.03.62-01 on any additional Zone Controllers.** 

# **Resolution And Repair Procedure**

In order to revert a Zone Controller to an earlier version, the disaster recovery procedure for a Virtual Machine must be used.

## Time To Implement/System Impact

Estimated time to implement - per machine - up to 4 hours

System Impact: Medium - Loss of Zone Controller redundancy during recovery
