After some period of time following an ATR upgrade to AN2024.1, new ATIA messages are not displayed on ATIAlog Viewer, new statistics are not displayed in Historical Reports and RCM reports are not being generated.

Technology

Severity Recommendation

High/Safety - Perform Immediately - if upgrade was performed to A2024

Symptoms

The following issues may be observed on ATR after an upgrade to AN2024.1:

On the ATIAlog Viewer, new ATIA messages are not available. The partition: /opt/Motorola/stm/atialog/logs becomes full, as a result new ATIA packets are not collected.

On the Historical Reports, new statistics are not available. The partition: /opt/Motorola/stm/stats/stats_files becomes full, as a result new statistics are not collected.

New scheduled RCM reports are not being generated. The partition: /opt/Motorola/stm/reports/export becomes full
