## How to Use the Documentation Library CD

Once the CD is in your CD-ROM drive, follow the installation prompts. From the DEFINITY ONE Communications System main menu, use Adobe® Acrobat® Reader to view the documents on the CD. If you know the document you want, you can use the main menu. From the main menu, select the document category, and then the document. If you want to find a word or phrase in the document, use the **Find** button on the Acrobat Reader toolbar (see below). If you want to find a word or phrase, but do not know which document to look in, use the **Search Query** button (see below).



Use the **Find** button to find a word, part of a word, or phrase in the current document. Acrobat Reader looks for the word by reading every word on every page in the document that you are in.



Use the **Search Query** button to look for a particular word or text string on the entire CD. Acrobat Reader shows you a list of all the documents that contain the search string. You can move through these occurrences one at a time until you find what you need.
