**Abstract**

This IL provides industry notification of the impending split of the 303 NPA.

Letter Information (Includes safety liability disclaimer (if applicable), ordering information, originator's signature information)

We have been advised by US WEST that substantial telephone number growth in the Denver area of Colorado necessitates splitting the existing 303 Numbering Plan Area (NPA) and the simultaneous introduction of a new 970 NPA.

The Denver metropolitan area will retain the 303 area code, and the remainder of the current 303 NPA will be transferred to the new 970 area code.

The split of the 303 NPA, and the beginning of a permissive dialing period, will take place 12:01 AM on Tuesday, April 2, 1995. The permissive dialing period will end 12:01 AM on Thursday, October 1, 1995. During the permissive dialing period either 303 or 970 will be acceptable in a dialed number terminating in the new 970 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

The dates that switching systems in the new 970 NPA will begin transmitting "970" in the calling number Automatic Number Identification (ANI) will be coordinated by US WEST with the interexchange carriers.

A test number for the new 970 NPA will be established on or about January 1, 1995 with details to be provided later.

Attachment A shows a map of Colorado with the new 970 NPA, the reduced 303 NPA, and the unchanged 719 NPA. Attachment B provides a listing of all NXX codes and offices which will remain in the 303 NPA, and Attachment C lists the codes and offices which will transfer to the new 970 NPA.

The dialing plan for the new 970 and 303 NPAs will be the same:

- All home NPA (HNPA) "local" calls will be dialed on a 7 digit basis with no prefix; i.e., NXX + XXXX (7 digits).

- All foreign NPA (FNPA) "local" calls will continue to be dialed on a 7 digit basis with no prefix, i.e., NXX + XXXX (7 digits).
- All HNPA direct dialed "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All FNPA direct dialed "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).


