Abstract

This IL provides industry notification of the introduction of NPA 562 for relief of the 310 NPA.

Letter Information (Includes safety liability disclaimer (if applicable), ordering information, originator's signature information)

We have been advised by Pacific Bell that substantial telephone number growth in the Los Angeles area necessitates the activation of an additional NPA to serve this area. The new NPA, 562, will go into service at 12:01 AM on September 2, 1995. The 562 NPA will overlay the existing 310 NPA, i.e., 562 NPA will cover the same geographic area as the 310 NPA. Pacific Bell has indicated that while no number changes are anticipated at this time for telephone subscribers in the 310 NPA, future jeopardy conditions may change this requirement.

The 562 NPA will be implemented as a "general purpose" overlay, however, assignments will be made initially to service providers at the tandem switch level, i.e., all services that connect directly to a tandem switch. No later than fourth quarter 1996, after upgrades have been made to local exchange carriers' operational support systems, number assignments from the 562 NPA code will begin for all service providers.

Current dialing procedures will be used in the 562 NPA, namely:

- All home NPA (HNPA) calls within the 562 NPA, may be dialed on a 7 digit basis, i.e., NXX + XXXX (7 digits), or with a prefix "1" and 10 digits, i.e., 1+ HNPA + NXX + XXXX (1 + 10 digits), as desired.
- All foreign NPA (FNPA) calls outside the 562 NPA will be dialed with a prefix "1" and 10 digits, i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- All operator assisted calls, including credit card, collect, and third party calls, will be dialed with a "0" prefix and 10 digits, i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).

The attached map illustrates the 310 and 562 configuration after the overlay has been implemented. Initially, the new 562 NPA will be served from the following tandem switches:

GRDN	CA	03	86T	Pacific Bell
LNBH	CA	XP	45T	GTE
SNMN	CA	XP	43T	GTE

Pacific Bell will provide a listing of the city/wire centers to be served by the 310/562 NPAs by the fourth quarter of 1996.

Test calls to verify routing to the new 562 NPA can be made by calling 562-317-0317. The test number will be in effect starting June 2, 1995. A recorded announcement will indicate that the test call has been successfully completed.
