**Abstract**

**This IL provides industry notification of the impending split of the 612 NPA.**

**Letter Information (includes safety liability disclaimer (if applicable), ordering information, originator's signature information)**

We have been advised by US WEST that substantial telephone number growth in the Minneapolis/St. Paul area of Minnesota necessitates splitting the existing 612 NPA and the simultaneous introduction of a new 320 NPA.

The Minneapolis/St. Paul metropolitan area will retain the 612 NPA. Customers outside this area will be transferred to the 320 NPA. Additionally, the exchanges of Red Wing (380, 385, and 388 NXXs), Wabasha (565 NXX), Goodhue (923 NXX), Lake City (345 NXX), and White Rock (258 NXX) will be transferred to the 507 NPA in southern Minnesota. Some customers in these exchanges will be required to undergo total telephone number changes because of the prior assignment of the NXX codes 345, 380, and 388 in the 507 area code.

The split of the 612 NPA, and the beginning of a permissive dialing period, will take place 12:01 AM CST on Sunday, March 17, 1996. The permissive dialing period will end 12:01 CDT on Sunday, September 15, 1996. During the permissive dialing period, either 612 or 320 will be acceptable in a dialed number terminating in the new 320 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

All international and domestic carriers are asked to ensure that the new 320 NPA has been activated throughout their networks prior to March 17, 1996. A toll-free test number for the new 320 NPA will be established by March 1, 1996 for test calls to the new area code. The test number will be 320-252-0090.

The attached map illustrates the 612 and the 320 NPA configuration after the split, including the areas that will be transferred to the 507 NPA. A listing of the communities to be served by the 612 and 320 NPAs after the split, including the respective central office codes (NXXs), is also attached.



The dialing plan for the new 320 and 612 NPAs will remain the same:

- All home NPA (HNPA) "local" calls will be dialed on a 7 digit basis with no prefix; i.e., NXX + XXXX (7 digits).
- All foreign NPA (FNPA) "local" calls will continue to be dialed on a 7 digit basis with no prefix, i.e., NXX + XXXX (7 digits).
- All HNPA direct dialed "toll" calls (generally calls that incur an extra charge) will be dialed with a prefix "1" and 10 digits; i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All FNPA direct dialed "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).





Figure 2. 612/320 AREA CODE DETAIL
