Abstract:

This IL provides industry notification of the impending split of the 216 NPA.

Letter Information (Includes safety liability disclaimer (if applicable), ordering information, originator's signature information.)

We have been advised by Ameritech that substantial telephone number growth in the Cleveland area of Ohio necessitates splitting the existing 216 NPA and the simultaneous introduction of a new 330 NPA.

The split of the 216 NPA will occur along north/south lines which approximate the Cleveland LATA boundary. The greater Cleveland area will retain the 216 NPA.

The split of the 216 NPA, and the beginning of a permissive dialing period, will take place 12:01 AM EST on Saturday, March 9, 1996. The permissive dialing period will end on 12:01 EDT on Saturday, June 29, 1996 for all wireline customers and on July 1, 1999 for all current and future wireless customers. During the permissive dialing period, either 216 or 330 will be acceptable in a dialed number terminating in the new 330 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

All international and domestic carriers are asked to ensure that the new 330 NPA has been activated throughout their networks prior to March 9, 1996. A toll-free test number for the new 330 NPA will be operational by January 6, 1996 for test calls to the new area code. The test number will be 330-783-2330. Calls successfully completed to the test number will receive a recorded announcement. The test number will be discontinued on June 29, 1996.

The attached map illustrates the 216 and the 330 NPA configuration after the split. Also attached is listing of the central offices and the associated central office codes (NXXs) to be served by the 216 and 330 NPAs after the split. The current wireless NXXs that will have their permissive dialing period extended to July 1, 1999 are identified with an asterisk on the attached listing.

The dialing plan for the new 330 and 216 NPAs will remain the same:


- All home NPA (HNPA) "local" calls will be dialed on a 7 digit basis with no prefix; i.e., NXX + XXXX (7 digits).
- All HNPA direct dialed "toll" calls (generally calls that incur an extra charge) will be dialed with a prefix "1" and 10 digits; i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All FNPA direct dialed "local" and "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).
