Abstract:

**This IL provides industry notification of the impending split of the 804 NPA in Virginia.**

We have been advised by Bell Atlantic that substantial telephone number growth in Virginia necessitates splitting the existing 804 NPA and the simultaneous introduction of a new 757 NPA.

The 804 NPA will continue to serve all Bell Atlantic - Virginia customers in the Richmond, Lynchburg and Charlottesville Local Access and Transport Areas (LATAs). The new 757 NPA will serve Virginia's eastern shore and much of the southeast corner of the state, including the lower peninsula (Williamsburg, Newport News and Hampton) and the South Hampton Roads area (Norfolk, Portsmouth, Virginia Beach and Chesapeake).

The split of the 804 NPA, and the beginning of a permissive dialing period, will take place at 2:00 AM EDT, on Monday, July 1, 1996. The permissive dialing period will end at 2:00 AM EST on Saturday, February 1, 1997. During the permissive dialing period, either 804 or 757 will be acceptable in a dialed number terminating in the new 757 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing, based on data provided by Bell Atlantic, will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG) and will be available April 1, 1996.

Central offices in the area to be served by the 757 NPA will be modified on a progressive basis to transmit the 757 NPA in the calling number Automatic Number Identification (ANI) between July 1, 1996 and November 1, 1996. Bell Atlantic - Virginia will convert all pertinent records to the 757 NPA the weekend of November 8-11, 1996. This includes customer service records and associated NPA information in other systems. After November 11, 1996, all inquiries must refer to the correct NPA code.

The attached map illustrates the 804 and 757 NPA configuration after the split. Also attached are listings of the communities and the central office codes (NXXs) to be served by each area code after the split. The NXXs on the attached are those in effect as of 1/19/96. Revisions to the NXX listing may be found either in the LERG or the NNAG. Current information concerning NXXs in these publications is available by license contract from the Bellcore Traffic Routing Administration (TRA) group, which can be contacted by dialing the TRA Hotline at (908) 699-6700.

All international and domestic carriers are asked to ensure that the new 757 NPA has been activated throughout their networks prior to July 1, 1996. Test calls to verify routing to the new 757 NPA can be made by dialing 757-627-1615. The test number will become available on June 1, 1996 and will remain operational until March 1, 1997. A recorded announcement will indicate that the test call has been successfully completed. Calls to report troubles in reaching the test number should be directed to 1-800-672-2628.

The dialing procedures for the new 757 NPA are as follows:

- All home NPA (HNPA) and foreign NPA (FNPA) direct dialed local calls will be dialed on a 7-digit basis with no prefix; i.e., NXX + XXXX (7 digits).
- All HNPA direct dialed toll calls (generally those calls incurring an extra charge) will be dialed with a prefix "1" and 10 digits, i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All FNPA direct dialed toll calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls (both HNPA and FNPA) including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).


